Should consumption vouchers be encashed?

The Government today issued a reminder to the public that consumption vouchers must not be encashed. It further explained that the consumption vouchers must be used at local retail, catering and service outlets or their online platforms that accept payments by six stored value facilities (SVFs).

What is the usage and coverage of consumption vouchers?

The usage and coverage of consumption vouchers are the same as the CVS last year. The vouchers can be used at local retail, catering and service outlets or their online platforms. However, the vouchers cannot be used for payments to the Government, public utilities, person to person payments and encashment, etc.

Where can I use a voucher?

The Government reminds members of the public that the vouchers must be used at local retail, catering and service outlets or their online platforms which accept payments by the stored value facilities (SVFs) under the scheme (i.e. AlipayHK, BoC Pay, Octopus, PayMe from HSBC, Tap & Go and WeChat Pay HK).

How much are Hong Kong consumption vouchers worth?

Each eligible Hong Kong permanent resident and new arrival aged 18 or above will receive a total value of \$5,000 in two instalments. In order to disburse the consumption vouchers early, the Government will disburse the first instalment of voucher valued at \$3,000 using the registration data of last year's CVS.

Why are consumption vouchers being issued again in 2023-24 budget?

The Financial Secretary, Mr Paul Chan, said "I announced in 2023-24 Budget to issue consumption vouchers again in order to provide support to the general public and small and medium sized enterprises to the best of our ability when the community is at the early recovery stage and our economy has become relatively stable.
