Over the past decade, Japan has experienced rapid growth in Solar Photovoltaics (PV) energy, propelled by ambitious renewable energy targets.

Furthermore, the city offers subsidies for small and medium-sized enterprises to introduce energy-saving equipment and renewable energy facilities. The subsidy provides 50,000 yen per kW for solar power generation (up to 5 million yen) and 30,000 yen per kWh for storage systems (up to 600,000 yen) when installed together.
