What is included in a lease agreement for solar development?

A solar lease agreement for landowners often includes an option agreement, a lease agreement, and an easement agreement. The option agreement gives the developer the right to lease your property, while the lease agreement outlines the terms and conditions. The easement agreement allows the developer to access and use your property for evaluation, construction, operations, and maintenance.

What is a solar lease agreement?

This agreement is for leasing solar systems to residential customers and meant to be used by vertically integrated companies who finance and install systems. This residential lease agreement is created for companies that work with a network of third-party installation partners or financiers.

What is the difference between a PPA and a solar lease agreement?

In a PPA, you buy the net amount of solar power you use from the meter at a fixed rate per kWh. However, with a solar lease agreement, you generally pay a fixed monthly amount. That monthly amount allows you to use all the output energy the solar equipment generates.

How do I resolve a dispute with a solar lease agreement?

If there is any dispute regarding the solar lease agreement, the parties agree to resolve the dispute within 30 days using mutual discussion.
