Are solar panels harmed by cheap imports from Southeast Asian countries?

May 20 (Reuters) - The U.S. International Trade Commission determined on Tuesday that domestic solar panel makers were materially harmed or threatened by a flood of cheap imports from four Southeast Asian nations, bringing the United States a step closer to imposing stiff duties on those goods.

Did ITC overturn anti-dumping and countervailing duties on aluminum extrusion imports?

UPDATE: The U.S. International Trade Commission (ITC) on Oct. 30 overturned anti-dumping and countervailing duties issued by the U.S. Department of Commerce on aluminum extrusion imports from 14 countries.

The U.S. Department of Commerce has made final determination on import duties for aluminum extruders, impacting solar racking.

Should Congress support American solar manufacturing?

After today's decision, it is more important than ever for Congress to support American solar manufacturing. What does a 'yes' vote mean for the ITC?

The "yes" vote by the three-member ITC means the Commerce Department will issue orders to enforce countervailing and anti-dumping tariffs on solar products imported from Malaysia, Thailand, Cambodia and Vietnam that the agency finalized last month.

What does the ITC decision mean for importers?

The ITC decision means that anti-dumping and countervailing cases against these nations will be terminated and all duties collected by U.S. Customs and Border Protection will be refunded to importers. Original reporting below
